



Effective in hard water up to 400 ppm hardness calculated as Ca CO3 in the presence of 5% soil. This product is for use on hard, non-porous surfaces in: Veterinary clinics, animal life science laboratories, animal laboratories, animal research centers, animal quarantine areas, animal holding areas, dog/cat animal kennels, pet animal quarters, pet shops, operating rooms, washing areas, waiting rooms, examination rooms and other animal care facilities.

This product can be used on washable hard, non-porous surfaces such as: Kennel runs, cages, kennel/cage floors, conductive flooring, veterinary x-ray tables, glazed porcelain, glazed tile, glazed ceramic, plastic, chrome and vinyl, enameled surfaces, stainless steel, brass, copper, floors, walls, ceilings, fixtures, and countertops.

This product is effective against Canine Parvovirus**.

FUNGICIDAL PERFORMANCE: This product kills the following fungi in 10 minutes at 1 oz. per gal. of water and 5% soil on hard, non-porous surfaces: Candida albicans. Trichophyton mentagrophytes

MILDEWSTATIC PERFORMANCE: This product controls the following mold in 10 minutes at 1 oz. per gal. of water on hard, non-porous surfaces: Aspergillus niger

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. FOR USE AS A ONE-STEP, GENERAL DISINFECTANT, FUNGICIDE, VIRUCIDE*,

CLEANER:

- Pre-clean heavily soiled areas.
- Apply use solution of 1 oz. of this product per gal. of water to disinfect hard, non-porous surfaces with a sponge, brush, cloth, mop, by immersion, auto scrubber, mechanical spray device. For spray applications, spray 6-8 inches from surface. Do not
- breathe spray.
- Treated surfaces must remain wet for 10 minutes.
- Allow to air dry.
- Prepare a fresh solution daily or when visibly dirty.

Repeat treatment every seven days, or more often if new growth appears.

FIRST AID

Remove all litter, droppings and manure from floors, walls and surfaces of barns, pens, stalls, chutes and other surfaces of facilities and fixtures occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean surfaces with soap or detergent and rinse with water.

FOR USE AS AN ANIMAL PREMISE DISINFECTANT/VIRUCIDE*: Prepare a use solution of 1 oz. of this product per gal. of water (1:128) (660 ppm active) for effectiveness against designated animal viruses on the label.

FOR USE AS AN ANIMAL PREMISE DISINFECTANT/VIRUCIDE**: Prepare a use solution of 4 oz. of this product per gal. of water (1:32) (2600 ppm active) for effectiveness against designated animal viruse on the label.

Apply use solution to disinfect hard, non-porous surfaces with a sponge, brush, cloth, by immersion, mechanical spray device. For spray applications, spray 6-8 inches from surface. Do not breathe spray. Immerse all halters and other types of equipment used in handling and restraining animals, as well as forks, shovels, and scrapers used for removing litter and manure in the use solution. Treated surfaces must remain wet for 10 minutes. Ventilate buildings, coops and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub all treated feed racks, troughs, automatic feeders, fountains and waterers and other treated equipment which can contact food or water with soap or detergent, and rinse with potable water before reuse.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store only in original container. Keep this product under locked storage sufficient to make it inaccessible to children or persons unfamiliar with its proper use.
